Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Ordered that in consequence of a certificate from his Excellency the Governor Henry Lee that Mary Whitt the widow of Shadrach Whitt who was a Soldier in the Army of the United States and died in the service be added to the list of Pensioners of this County with an allowance of 12 pounds annually to commence on the first day of January 1793. And it is further ordered that the Sheriff pay the same out of the money collected for the revenue tax.

Charles City County Court

October 1792.

Ordered that the Clerk of this Court do certify to his Excellency the Governor and Council, that Mary Whitt is the Widow of Shadrach Whitt who died a Soldier in the Army of the United States in the year 1776, and that the said Mary was left a very poor Woman with two infant Children in bringing up whom she laboured under great difficulty through her extreme indigence: and that John Whitt now living is the eldest Son of the said Shadrach Whitt deceased.
