Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." September 15, 1789

Ordered that John Skaggs be allowed a pension of eight pounds, he being wounded at the battle of Kings Mountain [October 7, 1780] so as to render him incapable of labouring for a sustenance and that the Clerk do certify the same to the Executive.

Law Order Book 2, Page 67 Pension - 1786 to 1792 of eight pounds per yr.

Bobby Gilmer Moss, in his *Patriots at Kings Mountain*, states that "John Skeggs, of what is now Tazewell County Virginia, was wounded while serving under Lieut. Reece Bowen, Capt. William Edmondson and Col. Campbell [William Campbell] at Kings Mountain."

To the Hon. the speaker and Gentleman of the House of Delegates for the Commonwealth of Virginia

The petition John Skegs humbly Sheweth

That your petitioner served as a soldier at the battle of Kings mountain in the year 1780 under the command of Col. William Campbell; that during the action, he received a wound in his right hand which has been so disabled thereby as to render him unable to support himself by labor.

That at a Court held for Washington County in the month of April 1783 your petitioner underwent an examination and obtained a certificate that he was a proper object of his Country's Bounty and ought to be placed on the pension list. – And that at a court held for Russell County in September 1789 he obtained another Certificate to the same effect: yet from a combination of circumstances he has never been placed on the pension list and consequently received no relief.

Your petitioner therefore prays that your Honorable body would take his distressed situation into consideration and place them on the pension list or do therein whatever in your wisdom may appear Just & right – & your petitioner as in duty bound shall Pray
