Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Hon. the Speaker and Members of the Senate and House of Representatives of Virginia

The petition of Martha Clark widow of Sampson Clark deceased, formerly of
Surry County humbly sheweth that your petitioner is advanced in years and is very poor, having
for many years been almost entirely dependent upon the bounty of her neighbors for support as
her age combined with bodily infirmity rendered her incapable of doing scarcely any kind of
labor, your petitioner is informed that her husband was a common Soldier in the Revolutionary
Army at the time of his death. The sufferings of your petitioner have been great indeed and but
for her ignorance this application for the bounty of her Country would have been sooner made.
Your petitioner being very old she cannot possibly long continue and expense to her Country.
She feels confident that the legislature of her native state will not suffer the widow of a soldier
who fault, bled and died in obtaining the liberty and independence of his Country to repine in
want and misery, the few remaining years of her existence, the accompanying certificate will
prove the facts above stated, and she trust will induce your honorable body to make for her such
provision as may seem just and equitable & she as in duty bound will ever pray —

Martha Clark's Petition December 20<sup>th</sup> 1813 (Rejected)

Surry County, to wit

We the subscribers do hereby certify that Martha Clark, Widow of Sampson Clark deceased is aged, infirm and in poor circumstances, & has been in this situation for a number of Years. We do further certify that her Husband Sampson Clark died when in the service of the Country as a Soldier during the Revolutionary War.
