## Bounty Land Warrant application of Edward Stevens VAS1923 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

Claim for Land Bounty Warrant for services in the Revolution Edward Stevens presented by Col. R. Gamble Rec'd November 5<sup>th</sup> 1819

Edward Stevens a private in the Va. State line on Continental establishment Claim for land bounty Allowed for 3 years time if not already allowed. Feby 5<sup>th</sup> 1820

State of Kentucky Fayette County Sct.

This day Edward Stevens appeared before me a Justice of the Peace for said County and made oath that in 1776 in Orange County Virginia he substituted for his Brother William Stevens as a Regular Soldier in the 7<sup>th</sup> Virginia Regiment commanded first by Col. William Daingerfield and afterwards by Alexander McClanachan, in the Company commanded by Capt. Joseph Spencer [?] That he served in said company & Regiment for part of two [?] years in his Brother's place and was then reenlisted for 3 years by Lieut. [indecipherable name] afterwards Capt. in the 7<sup>th</sup> Regiment and afterwards the 7<sup>th</sup> Regiment was transferred to the 3<sup>rd</sup> Regiment commanded by Col. Wm Heath [William Heth]. That he [indecipherable word] in said service until he was taken prisoner at "Charles town" [Charleston South Carolina] by Sir Henry Clinton. That while he was Prisoner at Charles Town his 3 years expired & he made his "Escape" which many other privates did from the same place. He further states that he was in the Battles of Brandywine [September 11, 1777] & Monmouth [June 28, 1778] that he served in the North [several indecipherable words] then 4 years 3 years under his on enlistment as a Regular soldier and more than one year as a Substitute for his Brother William Stevens. That [paper damaged and text rendered illegible] resides in Kentucky [paper damaged and text rendered illegible] 58 years that the manner in which he escaped as a Prisoner from Charles Town prevented his getting a Discharge. That he has never received his Land from Virginia [the balance of this document is posted in split image and I have not attempted to transcribe it] [attested by Matt Elder, JP]

[Note: This file also contains what appear to be supporting affidavits given by Richard Price, late a Sergeant and John Nelson late a Lieut. but the images of their affidavits are posted by split image which I have not attempted to transcribe. In addition, the handwriting of the scribe, presumably Matthew Elder, JP, is absolutely atrocious and very difficult to decipher.]
