## Pension application of John Valentine VAS1955 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

I do hereby certify that John Valentine of the County of King William, State of Virginia, enlisted in the year 1777 under Richard Crump in the State Artillery and served till the year 1780, when he was discharged. – I was a first Lieut. in the same Regiment with the said Valentine and knew him very well – he is now a near neighbor of mine. Given under my hand this 11<sup>th</sup> day of June 1812

The Petition of John Valentine of the County of King William, most respectfully represents to the General Assembly of Virginia, that he enlisted as a soldier in the Revolutionary war, in the year 1777, for the term of three years, under Capt. Richard Crump in the state Regiment of artillery commanded by Col. Charles Marshall [sic, Thomas Marshall?], that upon the division of the Regiment he was assigned to that part which was stationed at Fort Nelson [at the Falls of the Ohio River, now Louisville] under Col. Matthews where he continued until the Fort was burned by the British, after which he was stationed in Portsmouth, until the spring of 1780, when the different parts of the aforesaid Regiment were again United at Williamsburg, from whence they were marched to Charleston South Carolina under the command of Col. Edmunds (the said Col. Matthews having resigned) – that he was marched on to Salisbury from thence he was sent back to Hillsboro, where he remained until he was discharged, which was on the 6<sup>th</sup> day of August 1780 by Major Mazarett by order of Col. Charles Marshall having served about three years – Your petitioner further represents, that he is now sixty-seven years old, that he has been for the last twenty-five years entirely incapable of doing any work whatever for a support, from a severe and continued attack of the rheumatism – that frequently he is unable to get out of bed and but seldom enabled to walk. Your petitioner further represents, that he is extremely poor, that the only property he possesses is about one hundred acres of the poorest

land in the County of King William – that he has no slaves to work it, and that the little that he derives from it, is solely from the labor of one of his sons, upon whom devolves the entire care and support of your petitioner; and that but for the charity of some of his neighbors, he should have been destitute frequently of the common necessaries of life. –

Your petitioner further represents that one of his sons, about thirty years of age, was about five years past, taken with the disease with which he is afflicted, and has since been confined to his bed in the house of your petitioner, also dependent upon his other son who resides with him, for support. Your petitioner prays that your Hon. body will grant him an annual allowance or pension for the remainder of his life (which cannot be long) – or so much as his services may be considered to demand, and also permitting for his immediate, or present relief – and your petitioner will ever pray.

## King William County 3<sup>rd</sup> December 1827

John Valeatine.

I John Valentine do hereby certify that sometime in the year 1777 I enlisted for the term of three years under Capt. Richard Crump in the state Regiment of artillery commanded by Col. Charles Marshall, the Regiment was divided into three parts, one stationed at York, another at Hampton in the third commanded by Col. Matthews at Fort Nelson, where I continued until the Fort was burnt by the British, after which our party was stationed at Portsmouth until the spring 1780 when the three parties composing the Regiment joined at Williamsburg in order to proceed to Charleston to reinforce it and Col. Matthews resigned and Col. Edmunds took the command and marched directly to Charleston South Carolina but after passing Salisbury a council of war was held in the officers believing they had more artillery than was needful sent Major Mazarett back to Hillsboro North Carolina with about six field pieces one ammunition wagon and all the soldiers whose time would be out in August of which I was one, & I continued at Hillsboro until I was discharged which was the 26<sup>th</sup> day of August 1780 by Major Mazarett by orders of Col. Charles Marshall.
