Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Hon. the Speaker & the Members of both Houses of the General Assembly now sitting

The Petition of William Rose Humbly Sheweth

That early in the year 1777 your Petitioner was appointed by the his Excellency Gov. Henry [Patrick Henry] acting Quarter Master to all the Volunteer Troops, and militia then assembling or thereafter to be assembled in the City of Williamsburg, and continued to Act under the said appointment, and with Col. William Finnie, afterwards Quarter Master General for the Commonwealth, as his principal Assistant, until the 16<sup>th</sup> of February 1780, as appears by the Certificate hereto annexed, and to which he begs leave to refer.

That conscious of having performed his Duty to the satisfaction of the Public, and the Officers concerned –

He most humbly Prays that he may be allowed for his Services is full pay and depreciation in the same Manner and proportion as has been granted to the Quarter Master General, and other Officers of the Staff Department –

I certify that Mr. William Rose served me as an Assistant Quarter Master General for this State from the 1<sup>st</sup> Day of March 1777 to the 16<sup>th</sup> Day of February 1780, and that he faithfully and honorably discharged the Duties of his Station.
