I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." The petition of Daniel Dean respectfully Sheweth, that During the Late War, your Petitioner served three years in the Character of a Sergeant in the Second State Regiment, as will appear by a Certificate<sup>1</sup> signed by John Lee, late Major  $2^{nd}$  Virginia State Regiment, and that your petitioner has not received his pay and depreciation as will appear by a certificate<sup>2</sup> from the Auditor – your petitioner therefore prays that the legislature will take his Case into Consideration, and pass a law Authorizing the Auditor of Public Accounts to Issue Certificates for his pay & Depreciation, as also Warrants for the Interest which have accrued thereon – and your petitioner will pray &c

At the Expiration of which time he was Discharged by Coto [sic, Colonel?] Nathaniel Gist which will appear by the Certificate<sup>3</sup> of John Lee Major of 2<sup>nd</sup> Virginia State Regiment your petitioner further states that some short time before the law expired for settling Claims Similar to that of your Petitioner your Petitioner put his Discharge into the hands of a Mr. Due [sic, Dew?] who was then a going to Richmond to have the same Settled for your Petitioner from having his said Claim Settled prior to the said discharge which prevented your Petitioner from having his said Claim Settled prior to the said Law expiring – your Petitioner further states that he has Never Received any Compensation for his Services aforesaid as will appear by the Certificate<sup>4</sup> of the Auditor hereunto annexed your Petitioner therefore prays that the Legislature will take his Case into Consideration and pass a Law authorizing the Auditor of Public Accounts to issue Certificates for his pay & Depreciation as also Warrants for the Interest that has accrued thereon & your petitioner will pray &c
