[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Legislature of Virginia Sitting in the City of Richmond.  
Your Memorialist James Chappell Humbly Sheweth.

That he served during the Late American War as Quarter Master to a Corps of volunteers under the command of Brigadier General Robert Lawson<sup>1</sup> by whom he was appointed and Commissioned. Also as Quarter Master to a Detachment of militia marching from Halifax and the bordering Counties, under the command of Colonel Peter Rogers who gave the Appointment as will appear by the Evidence is attending this Memorial. In neither of which cases as your Memorialist been Compensated.

Your Memorialist begs leave to suggest that his Object in Delaying Application to this late day, was owing to the Inconsiderable provision made for such Claims. Incident to the Low State of public resources and Consequent reduced Credit: But as the State of Affairs is happily Changed, and finding that Others having served at the same time have been rewarded, I am induced to hope that my long waiting will not ultimately Exclude me from those benefits that my Countrymen in Similar Circumstances have Enjoyed And the Just reward for faithful Services.


By advertig to the Brigade and Regimental Returns it will be found that your Memorialist was appointed and did serve as herein stated, And the pay Rolls of some will prove that he was not compensated. Your Memorialist therefore prays that your Honors will consider the merit of his Claim and make such Provision for the same as in your Discretion may be thought Wise and Just &c and Your Memorialist will ever pray.








Halifax County September 13<sup>th</sup> 1781

This is to Certify that James Chappell is appointed to Act as a Quarter Master to the Militia under my Command, and he is hereby ordered to attend punctually to his Duty and the men to obey his Command as far as required agreeable to his Office.

I do hereby certify that James Chappell was ordered to march with the Militia from this County under the Command of Colonel Rogers, the 10<sup>th</sup> day of September 1781 to Join the Army

under the Command of the Marquis de Lafayette, that he marched according to orders, and that the Tour of duty was for three months agreeable to the act of Assembly.
