[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the General Assembly of Virginia

The petition of John Woodall of Halifax County Virginia September 30th 1829 Your petitioner begs leave to state that he is a Soldier of the Revolution, that he is old, poor and infirm and asks of your Honorable body a pension, to enable him to pass his few remaining days free from want, and with some little comfort – his friends & neighbors advised him to make this appeal to the Justice & liberality of his Country; his Own situation, his age, upwards of seventy years old, disease and infirmity rendering it impossible for his labor to support himself, unites with this advice, to induce him to appear before your Honorable body – his distress & situation does not result from intemperance or extravagant habits, as will appear by referring to the statement of his Neighbors – his labor since the conclusion of the Revolutionary war, is supported himself & his family, and with health & strength, would have continued to have done so in your Honorable body would never have heard a word from him about a pension – but age & disease renders that now a duty, that in other circumstances, he never had the least intention of doing – your petitioner, it is true was never in the regular service – but he performed more military duty, then some of those did who were in that service, & who are now receiving pensions – he don't say this with any view of detracting from their merits, but just to state the facts – he performed three distinct tours, and in the performance of those tours, was engaged in the well & hard fought battle at Guilford Court house [March 15, 1781] – your Honorable body is well apprized that the Virginia Militia performed their duty in that battle, as well & as bravely as any part of the troops – and that there was no flinching on their part on that Occasion – he was also engaged after the battle, in two other actions, on James River under General Lafayette – your Honorable body must also know, that Lafayette & his troops, performed their duty bravely & gallantly – & that there duty was laborious – these services are not now mentioned with any other view than to tell your Honorable body know that your petitioner has just grounds for he is making this appeal to them for a little support in his old age – having thus contributed when young & active towards the establishment of that liberty & independence that all now enjoy & the bad of which all acknowledge – and pressed down in his old age by misfortunes that he could not avert – he hopes your Honorable body will extend to him the same relief that others that have done no more than he has done & are now receiving & your petitioner will ever pray &c September 30th, 1829.

The undersigned are acquainted with John Woodall – his statement in the foregoing petition,

respecting his revolutionary services they fully believed to be literally correct – he is a man of truth, of respectable Character and of industrious & frugal habits – he is an old man & seems to be very infirm & unable by his own labor to support himself & he is old
