# Petition relating to William Rowe VAS1983 Transcribed by Will Graves

5/13/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speakers and Members of both Houses of General Assembly

The petition of Isaac Anglin and Charles Graiton asked in a William Rowe Humbly
Sheweth

That your Petitioner Isaac and was possessed of a Certificate for the sum of Sixty pounds three shillings granted him for his services as a soldier in Colonel Nathaniel Gist's Regiment & Company of Captain Alexander Breckenridge. Your petitioner Charles Graiton was also possessed of one as ass in me of William Rowe for his services performed as a Soldier in Colonel James Wood's 12<sup>th</sup> Virginia Regiment and in Captain Andrew Wallices [Andrew Wallace's] Company which certificate amounted to fifty-six pounds thirteen Shillings which Certificates your petitioners deposited in the hands of Colonel Andrew Donnelly of the County of Greenbrier to draw all the Interest thereon and was by him lost to the very great Injury of your petitioners, as will more fully appear to your Honorable house from his information on that subject, Wherefore your Petitioners Humbly pray that Duplicate Certificates may Issue to them under such Rules & Regulations as you in your wisdom may think proper & your petitioners as in duty bound will Ever pray

## James Dowling<sup>1</sup>

It appears to your Comm. [Committee?] that the Petitioner during the late War, enlisted as a soldier in the Continental line. That whilst in service to the Southward he received a wound which rendered him unfit for service. In consequence thereof he was discharged from the Army.

That from the remote situation of the Petitioner from the Seat of Government he failed to make application with his vouchers for a settlement of his Account for pay & depreciation until the expiration of the law which authorized the same.

It further appears that to your Comm. from Certificates under the hands of Colonel Thomas Meriwether & the Auditor of public Accounts that the Petitioner's Vouchers in support of his claim or genuine & that the same hath not been adjusted.

#### William Arbuckle -

Setting forth that during the late War he enlisted as an Artificer at Fort Randolph & did duty there at from the year 1777 until the month of October 1778. That it was stipulated upon his enlistment that he was to receive whilst in service nine shillings per day – for his pay which was accordingly paid to him in the month of March & June in the year 1778. That he failed to make application for his depreciation of pay until the law authorizing the same was repealed and praying that the Auditor of Public of Public Accounts may be directed to Settle his Account for the same. And issue certificates to the amount that may be found due to him. Rejected
