[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Assembly of Virginia your petitioner Benjamin Taylor who was a soldier in Colonel George Slaughter's Regiment in the Western country humbly prayeth your attention, your petitioner in the year 1780 being in an engagement with the Indians received a ball in his arm which has almost rendered it useless and not knowing that he was entitled to a pension before the time for giving in his claim was expired, Humbly prayeth the Honorable house to make some provision for him and your petitioner will ever pray

At a Court continued and held for Fauquier County the 28th day of April 1789

Ordered that it be certified that Benjamin Taylor who was a Soldier in the troops of this State was wounded in Kentucky in the service of his country and is entitled to a pension

[Note: This file contains another petition by the veteran seeking a pension for services rendered in the Virginia State Troops under the Colonel George Slaughter. This petition is dated October 11, 1792. On the reverse of it there is a notation indicating that the veteran was awarded a pension of 15 pounds per annum with 10 pounds in arrears from April 28, 1789. In addition, this file contains the following certificate from George Slaughter.]
