In Court Continued & held for the County of Shenandoah on Friday the 27th[?] day of April 1787

James Robinson who was a soldier in the Continental Army under the Command of Colo William
Grayson [several undeciphered words] and raised in this state in Captain [undeciphered name] Company
who was wounded in the said service at the battle of Brandywine [11 sep 1777] he is about thirty six
years of age. Ordered that Doctor George Strother examine his wounds and [several undeciphered words].

By Virtue of the within Order I have examined the * Robinson and find that the said Robinson Receved a * arm which broke the Bone of his Arm also another * which makes him lame & renders him unable to ge* in part I am of an opinion that he should receiv* given under my hand this 27th of April 1787 Dr*

I do with the advice of the Council hereby Certify That James Robinson, aged about 36 years, late a Private in Grayson's Regiment and whose pay was at the rate of £24 pr annum was disabled in the service of the United States by a wound in the left arm and another in his hip, and that he is allowed the sum of Eight Pounds yearly to commence from the first day of January 1787

Given under my hand as Lieuten't Governor of the Commonwealth of Virginia (the Governor being absent) at Richmond this 23^d day of July 1787.

At a Court Continued and held for the County of Shanandoah on Friday the Twenty Ninth day of February one Thousand seven hundred and eighty Eight

James Robinson having produced a Certificate from under the hand of Beverly Randolph Esquire Lieutenant Governor as a pensioner for Eight Pounds due for the year one thousand seven hundred and Eighty seven it being made appear to the Court by William A. Booth that the said Robinson is the person to whom it [undeciphered word] Ordered that the Sheriff pay the said James Robinson the said sum of Eight pounds and take a receipt on this for the same Agreeable to an Act of Assembly in that case made and provided.

4th Then Received the above sum from the Sheriff [undeciphered word] James Robison

In pursuance of the within order I have examined James Robinson who was wounded in arm & hip, the wound in his hip is intirely sound tho' of great inconvenience to him. that in his arm being also heald, and it being rendered thereby very feble, he is incapable of hard Labour. given under my hand this 4th day of April 1789 [signed] A Bainbridge

Know all men by these preasents that we Elizabeth Robinson Exeutix John Sawyers & Stephen Allen Junier Executors of the Eastate of James Robinsons Deceased of the County of Shelby & state of Kentuckey do make & Constitute and appoint Robert Gamble of the citey of Richmond and State of Virginia, our true and lawfull attorney for us & in our names to Receive the arrears of pension Due from the State of Virginia to the late James Robinson which Remains unpaid up till the 18th July 1805 on which Day he deceased – and to Do all lawfull acts requisite for Effecting the Same. Hereby ratifying and Confirming all that our said attorny may lawfully do by Virtue hereof. In testimoney whereof we have hereunto Set our hands & Seals this [blank] day of 1806
