Bounty Land Record regarding Thomas Ruffin VAS2607 Transcribed by Will Graves 4VSL rev'd 11/17/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do hereby Certify that I was well acquainted with Captain Thomas Ruffin (formerly of the County of Dinwiddie) and who was a Captain in the Army of the United States in the Revolutionary War – that I was intimately acquainted with him, while he was stationed in Williamsburg, that during his illness in that place, where he died, I frequently attended him, and was at his funeral, which as well as I recollect was in the month of April in 1776.

I do hereby Certify that Thomas Ruffin of Dinwiddie County of Virginia was appointed a Captain in the Sixth Virginia Regiment on Continental establishment commanded by Colonel Buckner [probably Mordecai Buckner] in January or February 1776 and I do further certify that he died the City of Williamsburg in the service of his Country in April 1776 By reference to my orderly Book [text too faint to discern] that his funeral took place under Military Establishment on the 11th April.
