Thursday the 8<sup>th</sup> February

Mr John Calvert is appointed to employ proper persons to furnish necessary materials and superintend the building of a sea galley according to plan intended to be employed on James river of which when finished he is to have the command and is to engage the officers and seamen his certificates for the workmens wages & necessaries will be paid, when produced and the utmost expedition is recommended to him

The foregoing is extracted from a book filed in this department which appears to be the journal of the committee of safety

Extracts from the Petition

That the Petitioner enlisted her slave Cuffee in September 1777 on board of the Norfolk Revenge Capt John Calvert for three years. That she applied to Capt Calvert for a Certificate of the service of her man – which she could not obtain as Capt Calvert alledged that he had lost his books & could not remember for what time Cuffee enlisted

Filed with the petition are two documents. One a certificate of Mrs Sharply & the other an account vs the Commonwealth for the pay of Cuffee

Mrs Sharply certifies on oath that Cuffee was enlisted for three years with Capt Calvert sometime in the year 1777–

The other paper – The Account is made out for the wages of Cuffee – beginning on the 2<sup>nd</sup> day of Sept 1777 being shipped by Capt John Calvert a for 3 years at 3/ per diem. The account is made out up to 2<sup>nd</sup> of August 1779 & is credited with sundry payments.

This petition & its accompanying documents shew that Capt. Calvert was in service in 1777 & in August 1779 being more than 3 years from the time of his appointment in Feby. 1776–

United States Navy Yard/ Gosport December 3<sup>d</sup> 1830

I do Certify that I knew Captain John Calvert of the Virginia State Navy, during the Revolutionary War, and further that he commanded the "Norfolk Revenge Galley" during that period. I presume that Captain Calvert must have continued in the Navy during the whole of the war, or he could not have enjoyed the rank in society which he did – for, in those days it was not considered as suitable to withdraw from the public service before the termination of the War, or until after the Siege of York [19 Oct 1781].

James Barron [W12264]

J W Murdaugh on behalf of Albert Allmand & others the heirs of John Calvert represents that Calvert was commissioned a Captain in the State Navy on the 8<sup>th</sup> day of January 1776 and was ordred to [illegible word] a Galley & take charge of her himself. He [several illegible words] for building the galley. He also shews by a document marked A.B. that Capt Calvert was in the service as late as the 20<sup>th</sup> day of August 1778 as it appears by the record of the Navy commissioners, that sundry letters were sent to [several illegible words] day – The Journal extends only ten or twenty days beyond the last record of Capt Calverts name which is on the 20<sup>th</sup> of Augt. and the Journal stops on the 15<sup>th</sup> of Sept. From the time of his commission on the 8<sup>th</sup> January 1776 to the last accounts of him on the Journal the 20<sup>th</sup> of Aug't 1778 is to two years and nearly eight months, being only four months short of three years, which no doubt could have been proven by the record had the [several illegible words] of the Revenge. And also a certificate of Commodore Barron that he was in the service

J W Murdaugh very respectfully suggests to the Council, whether it would be too great [several illegible words] that Capt Calvert continued the full term of three years, when by a mutilated and imperfect record he is shown at the end of that record to have served two years and eight months. Capt Calvert was a man of great wealth & that circumstance might have prevented him from applying for his bounty in his lifetime July 28<sup>th</sup> 1831/J W Murdaugh

The claim of Capt Calvert is advised to be rejected there being no evidence going to shew when he was commissioned or how he was discharged from the Service D. A. Wilson
