Know all men by these presents that I Thomas Condell of Montgomery County & state of Maryland Late a Soldier in the Service of the Continental army & in Colo Armands [Charles Armand: BLWt2291-850] Legionary Corps do make Constitute & appoint Clement Green of the County & State aforesaid my True & Lawful attorney for me and in my Name to Receive from the Register of the Land office all warrants for lands due me for my Services in the said Legionary Corps. I Hereby Ratifying & Confirming all That my said attorney shall Legally do in the premises

In Testimony whereof I Have here unto Set my hand & Seal this [illegible] day of December 1799 Signed Sealed & Delivered Thomas hisXmark Condell in the presents of John Edwards
