## Pension application of William Self, James Self & Caleb Oldham VAS330 <u>vsl 4VA</u> Transcribed by Will Graves 12/17/12 rev'd 4/19/21

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## [From rejected pension records in the Library of Virginia]

The affidavit of Thomas Self aged about seventy-three years taken at Hudson's Store in Northumberland County & State of Virginia by Thomas Bell a Justice of the peace for the said County the 9<sup>th</sup> day of July 1831.

The Affiant being first duly sworn according to law deposeth and saith that he knew William Self & James Self formerly of said County of Northumberland, that they enlisted in this state's service for five years. That they served the major part of that time and both died in actual service but at what particular times he cannot say. – And this affiant further saith that he also knew Caleb Oldham formerly of the aforesaid County that he enlisted at and for the same time in the same service as the aforesaid William & James and that he the said Caleb was killed in actual service, and further this affiant saith not.
