Virginia documents pertaining to Joseph Deloge VAS3349 Transcribed and annotated by C. Leon Harris.

[The following are from rejected claims in the Library of Virginia.]

KNOW ALL MEN BY THESE PRESENTS, That we, Paul Deloge, Lewis Deloge, Eulah Deloge, Benjamin Legotry[?] and Ellene Legotry, his wife, and John B. Deloge, Heirs at Law of Joseph Deloge, do hereby constitute and appoint Burgess B. Long of Missouri our true and lawful Attorney to prosecute any claims to land or money that may be due from the State of Virginia and the United States, and to demand and receive from the proper offices in Richmond and Washington City any land warrant or warrants so due, and surrender them at the General Land office, in order to obtain certificates of scrip in lieu thereof [several lines not transcribed] As witness our hands and seals this 10th day of September A. D. 1834. [all the heirs signed with their Xs]

I David Nowlin clerk of the Circuit Court of said County, do Certify that it is proven in open court, to the satisfaction of said Court, that the within Joseph Deloge, was a private in the revolutionary war, in the Illinois regiment commanded by Col. George Rogers Clarke [sic: George Rogers Clark VAS269]; that he served between three and four years, when the regiment was discharged [April 1783] and that he never received a warrant for the Bounty Land promised him, either on the part of the United States or the State of Virginia, nor did he ever transfer his Claim to it in any manner whatsoever. It is further proven that the said Joseph Deloge died intestate, and that the within named, Parties to this instrument, are the only Heirs.

In testimony whereof I hereunto subscribe my name and affix my official Seal at Waterloo this 12th day of September AD 1834 David Nowlin Clerk

Report upon the Claim of Joseph Deloge's heirs for bounty land for his services, as a private in the Illinois Regiment.

The Governor/ Sir, The name of Joseph Deloge is not on any of the Payrolls of the Companies in the Illinois Regiment, which have been preserv'd. His name has not been found on the Army Register of the State line.

The Clerk of the Circuit Court of Monroe County & State of Illinois has certified that it has been prov'd, in open Court, to the satisfaction of the said Court, that Joseph Deloge was a private in the Revolutionary war, in the Illinois Regiment, commanded by Colo G. R. Clark and that he serv'd between three & four years, when the said Regiment was discharg'ed. (see Certificate of David Nowlin Clk &c.) Respectfully submitted/ John H Smith Com;r &c/ June 9th 1835
