Virginia documents pertaining to Mathew Donovan VAS3400 Transcribed and annotated by C. Leon Harris.

[The following are from <u>bounty-land records in the Library of Virginia</u> indexed as Donavan, Mathew. Some documents in the file are not transcribed because they are either illegible or not considered significant.]

To his Excellency David Campbell Gov. &c.

The petition of Richard D Rollins only heir of Maj. Mathew Donovan of the Va. Cont'l line, represents that said Donovan was commissioned 17th January 1776 as Major in the Va. Cont'l. line, & that he died in the service in the early part of the same year – that in August 1835 the Executive of the Com[monwea]lth allowed y'r petitioner Bounty land for 3 years only – that he considers himself entitled to additional Bounty for upwards of one year & three months & prays the allowance thereof. He refers to the papers filed & acted on in August 1835 & the references made therein to the record as well as to the Com'rs. report filed therewith [not transcribed], which he respectfully submits, will sustain the foregoing statement. Case of Major Matthew Donnovan.

In the journals of the Convention (in the Library) 12th Jany 1776 the following resolution appears. "Resolved – that Matthew Donnovan be appointed Major to the 9rh Regiment" – Page 94.

In the 1st Vol. Virginia Gazette, appears the following obituary notice viz – "Deaths. Matthew Donnovan Esq. Major of the 9th Regiment. He was taken ill of a pleurisy, in Gloucester county & died in 9 days. He was a gentleman of great abilities, of much integrity & benevolence and a true friend to America, & no doubt would have made an excellent officer." (Va. Gazette. Vol. 1st Feby 9th 1776.

In addition to the evidence of his appointment & death in the service, the affidavit of John Eyre Esq of the E. Shore [Eastern Shore] of Va. is filed, confirming the above statements of public history. A reconsideration of the claim for Bounty Land is requested.

Northampton County Virginia This day [13 July 1835] came before me [undeciphered word] of the Sup'r Ct. of Law & Chancery in said County John Eyre of same County aged sixty seven years who deposeth & sayeth that tho but lad at the time that the events took place on which he is requested to give testimony yet does distinctly recollect that a certain Matthew Donnovan was a private teacher in the family of this the deponents father that he [several undeciphered words] by the conversation in the family that the aforesaid Matthew Donovan upon the breaking out of the war in 1775 did leave the family in which he had resided some years & the county aforesaid & joined the american troops then collected near Norfolk he well recollects the pride he felt at hearing of [several undeciphered words; see endnote] at the Battle of the Great Bridge [9 Dec 1775] & the sorrow of hearing soon afterwards of the death of said Donavan while in the service of his adopted country John Eyre

NOTE: The Commissioner's summary report for the governor paraphrases the last partially undeciphered passage as follows: "the said Donovan behav'd gallantly at the Battle of the great Bridge."
