To his excellency the Governor and the Hon. the Executive Council of of Virginia the following claims for land, on account of service in the revolution, are respectfully submitted.

- 1 The claim of Reuben Griffes is submitted on the evidence of Thomas Jues[?] Certifying that he served about three years to the best of his recollection, and the affidavit of Isaac Wesson, that he enlisted for three years and served the same as a non commissioned officer. He will be entitled to two hundred acres Continental
- 2. The claim of Wm Hackney for land for three years service as a soldier in the continental army is submitted on the affidavit of Thomas Dowden and Thomas Harris.
- 3. The claim of John Dowden for land for three years service in the Virginia continental army is submitted on the affidavit of Thomas Dowden.
- 4 &5. The claims of Jessee Williams and John Murfee for so much land as a soldier who dies in [illegible] may be entitled to (200 acres each) are submitted on the evidence of Thomas Harris and Thomas Dowden
- 6. The claim of Wm Wallace for so much land as one who died in service may be entitled to (200 acres) is submitted on the evidence of Thomas Harris and Thomas Dowden.
- 7. The claim of [the rest cut off at bottom of page]
- 8. The claim of Wiatt Epps for so much land as a sargeant slain in battle may be entitled to (400 acres) is submitted on the evidence of Thos. Dowden and Thos. Harris.
