## Southern Campaign American Revolution Pension Statements and Rosters

Virginia documents pertaining to Martin Loggins VAS3960 Transcribed and annotated by C. Leon Harris.

[From bounty-land records in the Library of Virginia.]

To his Excellency Wyndham Robertson Lieutenant Governor, Acting as Governor, of the Commonwealth of Virginia:

The Memorial of Catherine Collins widow of Thomas Collins Decd of Charlotte County, Virginia, formerly Loggins, of Simeon Cumby and Amy his wife, formerly Loggins, of Halifax County, Virginia, of Thomas Cumby and Dicey his wife, formerly Loggins, of Lunenburg County, Virginia, of Crawford Carter and Polly his wife, formerly Loggins of Nicholas County, Kentucky, and Saunders Loggins of Halifax County, Virginia, being the legitimate heirs at law of Martin Loggins Decd, late of Charlotte County, Virginia, who was a soldier and a corporal of the State line of Virginia on Continental establishment in the war of the Revolution. Your Memorialist beg leive most respectfully to state, that the said Martin Loggins enlisted first in the county of Charlotte as a soldier in the Continental service in the early part of the year, 1776, under Captain Ballard [probably Robert Ballard VAS2363] for the term of Twelve months, which period he served faithfully, and was honorably discharged. as soon as the said term of enlistment expired, the said Martin Loggins enlisted again in the Continental service under Captain Joseph Michaux [VAS882] in the early part of the year, 1777, for the period of Three years, and marched to the Northern Army under General Washington, where the said company was attached to the 14th Virginia Regiment, commanded by Col Charles Lewis [VAS901]. During the latter service he was made Corporal; he served in that capacity the full term of three years for which he enlisted, and was regularly and honorably discharged. He was altogether in the continental service four years successively. For evidence, your Memorialist refer to the annexed certificates, given by credible and respectable witnesses of his service, who were soldiers in the Revolutionary war, and with him in the Army – also to the original papers, Muster Roll of Capt Michaux [http://revwarapps.org/b192.pdf] &c &c, filed with the Memorial of the Heirs of Capt Michaux for Land Bounty, now in the hands of the Executive – your Memorialist farther state, that the name of "Martin Loggins, Corporal" will be found on "A List of non-commissioned officers and soldiers of the Virginia line on Continental establishment, whose names appear on the Army Register, and who have not received Bounty Land" reported by John H. Smith esq the Commissioner of Revolutionary Claims.

Your Memorialist, therefore, most respectfully pray that your Excellency will grant them, as the legitimate heirs at law of the said Martin Loggins Corporal, now deceased, the Warrant for the quantity of land, to which he was entitled, for service rendered in the War of the Revolution, pursuant to the laws of Virginia in such case made and provided. And your memorialist, as in duty bound, will ever pray &c &c

Virginia. Charlotte County to wit:

I William Vaughan [S14754] do hereby certify that early in, 1776, Martin Loggins of Charlotte enlisted under Captain Ballard for Twelve Months, and was stationed a part of the time at Norfolk, and a part at Williamsburg. I saw him a number of times at both places, in the fall of 1776, whilst a soldier in the continental line under Captain John Brent [VAS2630]. In the fall of, 1776, Capt Brents company marched to the North. About the time that Martin Loggins' term of enlistment under Captain Ballard expired, Captain Joseph Michaux raised a company of Regulars for the term of three years and marched them to the North. Martin Logins was one of his soldiers and I saw him again repeatedly in the Northern

Army. He serryed faithfully under both enlistments the full period, and was promoted as corporal in the last, and was honorably discharged. He was attached to the 14th Virginia Regiment on Continental establishment commanded by Col Lewis. He served longer than three years successively. Given under my hand this 8<sup>th</sup> day of June, 1836. William Varyhon

Virginia. Charlotte County to wit:

I John Foster [S1515] do hereby Certify that I was intimately acquainted with Martin Loggins in the Revolutionary war. In the early part of the year, 1776, he first enlisted under Captain Ballard in the continental service for Twelve months, which term he faithfully served, and was honourably discharged. Immediately after that service expired in the Spring of, 1777, he enlisted again in the continental service under Captain Joseph Michaux for the period of three years, marched to the northern army, was made Corporal, and served the full term of enlistment with credit. He was attached to the 14th Virginia Regiment on Continental establishment, commanded by Col Charles Lewis [illegible word] in the Northern Continental Line, most of the facts above stated, come within my own personal knowledge. Given under my hand this 11<sup>th</sup> day of June, 1836. - John Toctors witness

State of Virginia – Charlotte County to wit:

I William Hamlett [William P. Hamlett S13305] of Charlotte do certify that Martin Loggins late of Charlotte, now deceased, enlisted as a soldier under Captain Ballard for the term of twelve months in the continental army, during the Revolutionary war, in the early part of the year, 1776, and served his term of enlistment faithfully, and was regularly discharged. As soon as discharged from that engagement, he enlisted again in the Continental service under Captain Joseph Michaux for the term of Three years, which term he faithfully served. He enlisted under Captain Michaux in the spring of, 1777, and was attached to the 14th Virginia Regiment on Continental establishment, and before the expiration of his term of enlistment, was made a corporal. I was a soldier in the Revolutionary war, and had frequent opportunities of knowing the services of said Martin Loggins. Given under my hand this 6<sup>th</sup> day of June, 1836.

Virginia – Charlotte County to wit:

I James Mullings [S10251] do certify that Martin Loggins was a soldier in the State line of Virginia on Continental establishment during the Revolutionary war. He first served 12 months as a regular soldier under Captain Ballard, and was stationed the larger portion of the time near Williamsburg. About the time his term expired, he then enlisted under Captain Michaux for three years, and marched to the Northern Army. His first enlistment was in January or February of, 1776, and he marched under Captain Michaux in the early part of, '77, he was made Corporal whilst under Michaux, served the whole period faithfully, and was regularly discharged, His company was attached to the 14th Virginia Regiment on continental establishment commanded by Col Lewis James Neellings
