Georgia Greene County

Personally came before me John Mallory who being duly Sworn deposed and saith that he was a Soldier in the Revolutionary war in the Service of the United States, that he enlisted under Capt Ambrose Dudley for three years, in the Second Virginia State regiment, and that he was Regularly discharged by Col. William Brunt [sic: William Brent VAS2639], which said discharge is deposited in the Auditor's office in the City of Richmond Virgia. He the said John Mallory further deposed and saith that he was drafted agreeable to an act of the general assembly of the state of Virginia for the Term of Eighteen months in the County of Louisa which time he duly served under General Anthony Wayne, and was discharged by General Scott [Charles Scott BLWt2055-850] at Cumberland Old Courthouse [which] discharge was also [part missing at bottom of page] And whereas by an Act of the second Session of the sixteenth Congress of the United States passed the ninth day of February 1821 granting a further time to the Officers and soldiers of the Virginia continental line who were entitled to bounty lands, issued by the state of Virginia between the little Miami and Scioto Rivers for Locating the same this deponent saith that he hath not located nor receive any part of said land or any person for him & that he believes himself justly entitled to said bounty lands

This is to certify that John Mallory [VAS3985], Sergeant in the fifteenth Virginia Regiment enlisted the seventeenth day of December 1777, for the term of three years, and died January 1778.

A warrant of 200 acres issued 23<sup>rd</sup> June 1783 to Peter Mallory Heir & Legal representative of John Mallory Dec'd [VAS3985] for three years service of said John Mallory as a Serjeant of the Virginia Line on Continental Establishm't upon certificate of the Executive dated 28 Febraury 1783.

A warrant of 100 acres issued 3<sup>rd</sup> March 1784 to John Mallory for three years service as a private of the State Line, upon certificate of the Executive dated 3<sup>rd</sup> March 1783.

No other Land Bounty warrant appears to have issued for the services of John Mallory in the revolutionary war.
