Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I do with the advice of Council hereby Certify that William Wilborne, aged about 25 years, the a Private in a Detachment of the Virginia line under the command of Colonel Buford, and whose pay was at the rate of £24 per annum, was disabled in the Service of the United States by several wounds received at the Battle of Waxsaw [Buford's Defeat, May 29, 1780]; and that he is allowed the Some of Twelve pounds yearly from the first day of January 1786.

[Note: Lloyd de Witt Boskstruck, Revolutionary War Pensions Awarded by State Governments 1775-1874, the General and Federal Governments Prior to 1814, and by Private Acts of Congress to 1905, Baltimore, MD: Genealogical Publishing Company, 2001, p. 870 has an entry indicating that the veteran lost one hand and his other was much disabled at Buford's Defeat. The veteran was awarded a gratuity of £300 December 14, 1780. He was still listed on the pension list as of 1813. His name also appears as William Wilburn and William Wellboure. Leon Harris has discovered an entry in the Virginia pension files indexed under the name "Cook, ___" which contains the following note: "William Wilborne, a Soldier, wounded in Buford's Defeat and is considered unable to procure a living having lost one of his hands & the other much disabled." The document discovered by Leon contains references to a number of other disabled veterans or their widows and can be found in his transcription of John Clark VAS278.]
