Pension application of Nathaniel Wilkins VAS405 Transcribed by Will Graves <u>vsl 4VA</u> 1/15/13

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." It is hereby Certified that Nathaniel Wilkins, late of [illegible], was Private in the 7th Virga Reg. And was wounded in the Service of the United States occasioned the amputation of his Right hand. He is about 28 Years of Age

Given under my hand this 2nd April 1787 [indecipherable signature]

I do with the advice of Council hereby Certify that Nathaniel Wilkins, aged about 28 years, late a Private in the 7th Virginia Regiment whose Pay was at the rate of twenty-four Pounds per annum, was disabled in the Service of the United States by a wound which occasioned the amputation of his right hand; And that he is allowed the sum of Eighteen pounds yearly to commence on the first day of January 1786 –

Given under my hand as Lieutenant Governor of the Commonwealth of Virginia (the Governor being absent) at Richmond this 7th day of June 1787

He was living in Gloucester County in April 1787. It is stated that his wound was sustained at the battle of Waxhaw [May 29, 1780].]
