Southern Campaign American Revolution Pension Statements and Rosters

Virginia documents pertaining to George Satchell and William Satchell VAS4352

Transcribed and annotated by C. Leon Harris.

[From rejected claims in the Library of Virginia indexed as Satchell, George.]

Custis Bull Sr [possibly S18338] who is a man of truth and veracity made oath before me that he was well acquainted with William Satchell & George Satchell both of whom enlisted in the 9th Va. Regiment of the Cont'l line in the Revolutionary War & after being gone several years it was said & always believed that one of them was killed in battle & that the other died of the Small pox in the army.

Thomas Cropper Sen'r brother of the late Col. John Cropper [W3781] of the Army of the Revolution & a man of truth & veracity made oath before me that he was well acquainted with George Satchell & William Satchell – that they both enlisted in the 9th Va Regiment and after being gone several years, it was said & always believed that they both died in the service of the United States – but whether in battle or of disease the witness cannot recollect.

Levin Hyslop [W7858] a Revolutionary pensioner and a man of truth & veracity came before me and testified that he enlisted in Capt Blairs [John Blair VAS2518] Company of the 9th Va Regiment of the Cont'l line for 18 months, and then reinlisted for the War & served till the War ended and has drawn 200 acres of Land for his services & that William Satchell & George Satchell enlisted in the same Regiment & after serving out one tour reinlisted for the War, and one was killed, & the other died of disease in the army. The witness does not now recollect which was killed & which died of disease, but both lost their lives in service, after having been in the army several years as soldiers reenlisted for the War. 1833 March 22^d Swor to before me a Justice of the peace in & for Accomack County Wm. R. Custis

For further proof in support of the claims of the soldiers who enlisted in the 9th Va Regiment see the [undeciphered] of Sam'l Waples [Samuel Waples W6427] a Revolutionary Officer filed in the Claim of Isma Giddens [VAS522] soldier.

1833 May 18 Rejected

[From bounty-land records in the Library of Virginia indexed as Satchell, William.]

I certify that Robert Russell Sen'r [W5753] who is a man of truth & veracity and who is a Revolutionary pensioner came before me & made oath that he was well acquainted with George Satchell & William Satchell of this County – that said George & Wm Satchell entered into the service in the Va Continental line as soldiers when the 9th Va Regiment was raised & that they afterwards reenlisted as this deponent well remembers for the term of during the war and died of wounds received in service, after the Battle of Germantown [4 Oct 1777]. This deponent was taken prisoner in that Battle & confined in prison with [undeciphered word] Satchells & knew them well. Given under my hand and seal as a Justice of the peace in & for the County of Accomack this 21st day of January 1834 Wm. R. Custis J.P.

1834 Feby 11 Sold'r [undeciphered] Allowed for the war. J. F. [Gov. John Floyd]
