Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The <u>Virginia State Library</u> online digital collection relating to Bounty land warrant issued by that state contains the following documents relating to this veteran:

This is to Certify that John Story enlisted himself a Soldier in the 10th Virginia Continental Regiment the 8th of April 1777 to serve for the term of three years & that he said Story deceased 28 Jany 1778.

[Note: In an affidavit dated April 1818 given in Culpeper County Virginia, Peter Triplett² gave oath that John Story served as a soldier in the 10th Virginia Regiment in the year 1778 in the

North; that the affiant does not recollect when Story enlisted; that he, affiant, saw Story in military dress and has not heard of him since; John Lampkin³ who intermarried with Mary Story a sister of John Story made oath that John Story regularly enlisted and served as a soldier in the 10th Virginia Regiment under Captain John Spotswood; that he said Lampkin was in the service and frequently saw Story engaged in the service as a soldier. Mary Lampkin made oath that she is the sister of the above John Story; that she only had one other brother who she believes must be dead as she has not obtained any intelligence of him for a considerable number of years; that she is the eldest sister of John Story who she knows well died in the service of the United States [the digital image of her affidavit is cut off at this point] [The digital images of the above summarized affidavits are of very poor quality.]
