## Southern Campaign American Revolution Pension Statements and Rosters

Virginia documents pertaining to John Singleton VAS4460 Transcribed and annotated by C. Leon Harris.

[From rejected claims in the Library of Virginia.]

We George Suggs [S38320] of the Borough of Norfolk and Robert Waterson of the County of Princess Ann [sic: Princess Anne] in the State of Virginia, Soldiers of the Revolutionary War, do certify, that John Singleton now living in the Borough of Norfolk, State of Virginia, was a Soldier of the revolutionary war, and attached to Captain John Gregory's [VAS3768] company of Infantry 15<sup>th</sup> Regiment of the Virginia Line on continental Establishment, Commanded by Colo. David Mason [VAS506] and, after the resignation of Colo. Mason, was commanded by Colo. James Innes [VAS1344]; and we do further Certify that to our knowledge, he, the said John Singleton received an honorable discharge; As witness our hands & seals, at Norfolk, this fifteenth day of April, 1818.

George Suggs and Robert Waterson came before me a Justice of the Peace for the Couty aforesaid and made Oath that the facts stated in the within certificate are true – that the John Singleton now residing in the Borough of Norfolk is the same man alluded to in the said statement.

And I do further certify that John Singleton also made Oath before me that he is the same John Singleton who served in the Revolutionary war in Captain John Gregory's Company of Infantry, in the fifteenth Regiment of the Virginia Line on Continental establishment commanded, first by Colo. David Mason, and afterwards by Colo. James Innes. that he put the Discharge, which he obtained at the End of the War, into the Hands of Colonel Thomas Mathews [W17076 and R16019] of Norfolk, and has not seen it since; and he understands it cannot now be found.

I also certify that the aforesaid George Suggs & Robert Waterson are respectable inhabitants, the first of the Borough of Norfolk and the latter of Princess Ann County, and that full faith & Credit ought to be given to their certificate. Given under my Hand & seal the fifteenth day of April, one thousand eight hundred and eighteen.

This day Robert Waters [sic] of the County of Princess Ann & State aforesaid came before me Stephen Wright a Magistrate for the County of Norfolk and made oath that he enlisted in the 15 Virginia Reg't in the Revolutionary War to serve three years in the Continental line. that he was well acquainted with John Singleton in the same Regiment, now of Norfolk, that they both served out the time of enlistment, & was discharged at the same time in Philadelphia & returned to Virginia together they were discharged on the 20th December 1779 & returned in 1780. given under my hand this 21st day December 1824.
