This will certify That Ephram Wammack of Cap Winston's [John Winston VAS5050] Company Enlisted The 10th Day of Sept 1777 For the Term of Three years and No Longer Given under my hand this 26th Day of Dec'r 1779

Simson W Foster Ens [Simpson (Simon) Foster VAS3623]

I certify that the within mentioned Ephraim Womack was taken prisoner at Charlestown while in service [12 May 1780] and his term expired while in captivity. He served as a corporal in my regiment and behaved well.

State of Virginia Prince George County To Wit,

Personally came Thomas Dowden [W4181] of this County before me Franis E. River an acting Justice of the peace for said County & state who being duly swarn deposeth and saith that Ephraim Warmack of said County was an enlisted Soldier under Captain Peter Jones [S8772] as a Contineltan Soldier for the term of three years was in Colonel Davises first Virginia Continelton Ridgment and served three years and entered the war again and was taken Prisoner at Charles Town and exchanged for about the time of Cornwallace being taken at Little York [Cornwallis surrendered at Yorktown 19 Oct 1781] the whole time of his service was better than five years sworn to and subscribed before me this the Sixth of August Eighteen hundred and Thirty four

This deponent states that he is in his Eightyeth year of his age. Sworn to this 6th August 1834

Bryant an acting Justice of the Peace for said County and State who being duly sworn saith that Maryann Lundy Womack is the only surving Heir of Ephraim Womack Dec'd. formerly a Revolutionary Soldier and whose services are prooven by Thomas Dowden all of the County of Prince George and State aforesaid Swarn to and subscribed before me this 2nd of Oct'r Eighteen hundred and Thirty four.

The undersigned Heir of Ephraim Wamack formerly of Prince George Coty. beg leave respectfully to present their memorial for Land Bounty to the Executive of Virginia and in Support thereof to submit the

following statement, that your Memorialist are the daughter of Ephraim Wamack and are Citizen of Prince George County Va (and in the poor house of said County) that he enlisted under Captain Peter Jones in the Continetal service for three years in the first Virginia Rigment which was Commanded by Colonel Davis that he served the three years entered the war again and was taken a Prisoner at Charleston and was exchanged for about the time Cornwallis was taken at Little York the whole time of his service was more than four years, Your Memorialist verily believes believes herself entitled to Land Bounty for the services of Ephraim Wamak aforesaid and are induced to this Conclusion more from the reports of others than from any knowledge I myself possess on the subject, I therefore believe that if the Claim can receive the advantage of an investigation by the Commissioner appointed therefor, that it will be fully shewn I respectfully ask that this case may be considered and that such a a disposion may be made thereof as that Justice may be done Signed this 12 of November 1834
