Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Princes Anne County Sct.

William J Woodhouse a Justice of the peace for the said County do hereby certify that Thomas Bonney¹ and William Cannon personally appeared before me and made oath that they were soldiers in the revolution, and knows [sic] that Southy Mills was either a non-commissioned officer or private in Captain Thomas Mathews Company for three years and a half and that Southy Mills was with Mathews at the North two or three years of the time and returned to this place with him, and that Jacob Mills is the lawful heir of said Southy Mills – I moreover certify that the said Thomas Bonney & William Cannon all worthy of credit as witnesses.

Given under my hand & seal this 20th November 1830.

I Thomas Bonney of the County of princes and aged 72 years do hereby certify that Southad [sic] Mills was a Soldier in the Virginia State line in the war of the Revolution and was three years in service and was honorably discharged. Given under my hand this 13th day of April 1832

Petition for Bounty Land

Southard Mills soldier Continental line

The credible witness proves that this soldier enlisted & served for three years: and his is in [indecipherable word] reports supported by another credible witness.

The name of Southey Mills is on the Army Register. He received the sum of £16.17.10 the balance of his full pay, as a Soldier. Southard, and Southey, Mills were probably the same Individual; whose name was written differently at different times. He appears to be entitled to land for a service of three years.

If your Excellency should be of the opinion that bounty land all to be allowed, it should

To his Excellency Governor Tazewell

I John Pallett² of Princess Anne County do hereby certify that I was well acquainted with Southard Mills. I have a Distinct recollection of his enlisting in the regular service at an early Period of the Revolutionary War he was from this County. I lived about five miles from him I recollect when he went away, he went out under Captain Mathews, and he was gone some long time, he was gone at least three years, I have a distinct recollection of his coming home, after he came home he acted as fugleman³ for our Battalion I was in the Militia service myself I was intimate with Southard Mills and I have frequently conversed with him about the war and I have heard him tell about a Battle he was in which took place in a book wheat field in which the Americans got defeated and nearly all the Americans got killed. As witness my hand and seal this 4th day of June A.D. 1833.

I Thomas Bonney of Princess Anne County do hereby certify that I was well acquainted with Southard Mills. I recollect distinctly that he enlisted in the regular service in the revolutionary war for the term of three years about the year 1777 and that he did not come home until three years had expired. I lived about four miles from him after he returned home he was raised in this County where I was born and raised at I saw him frequently after he came home he acted as Fugleman to the Battalion I was then, after he came home, and I was quite intimate with him, he was a good soldier. I was in the militia service myself. As witness my hand and seal this the 5th day of June A.D. 1833.
