Pension application of Jesse Ruble [Rubel] VAS82 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

That he served in a Company of volunteer Militia at the time he was disabled and that he now resides in Brooke County¹ and has resided for the last three months previous to which he resided in Frederick County Virginia. Sworn to the 9th day of March 1802. [no indication this document was signed separately.]

[p 8: There are a number of powers of attorney whereby the veteran authorized others to receive his pavement of his annual pension. Several of these there a very good signature as he shown by the attached which indicates that he spelled his surname "Rubel"
