

In 1778 Monongalia County VA comprised much of what is now northern West Virginia and part of southwestern Pennsylvania. Col. Daniel McFarland was the County Lieutenant in charge of the Monongalia County Militia.

The "Act of Assembly" alluded to was "An Act for speedily recruiting the Virginia Regiments on the continental establishment, and for raising additional troops of Volunteers," passed in October 1777 (Hening's Statutes at Large. http://vagenweb.org/hening/vol09-16.htm). This act was necessitated by severe losses of Continental troops, especially of the 9<sup>th</sup> Virginia Continental Regiment at Germantown on 4 Oct 1777. Among other provisions, the act of October 1777 specified that a number of single, ablebodied men over age 18 and without children would be drafted from the county militias for one year. Selection was made by having each eligible man draw a slip of paper on which was written either "service" or "clear." Those who drew "service" received a bounty of \$15 and were exempt from future drafts after serving out their one-year's terms. The quota for Monongalia County was set at 40, which is the number of men listed above.

Garret Clawson's pension application W3776 indicates that he was in the 13<sup>th</sup> Virginia Continental Regiment, which was raised from the Western District of Augusta County, Yohogania County, and Monongalia County. According to E. M. Sanchez-Saavedra (*A Guide to Virginia Military Organizations in the American Revolution, 1774-1787*. Westminster MD: Heritage Books, 2007), five of the ten companies in this regiment went to the North and served in Washington's main army, while the remaining five companies were stationed at Fort Pitt at Pittsburgh and Fort Randolph at Point Pleasant. It is not clear where the 40 from Monongalia served, or whether they all served together. Sanchez-Saavedra states that the entire 13<sup>th</sup> Virginia Continental Regiment was stationed at Fort Pitt by 14 Sep 1778, when the White Plains Arrangement caused it to be renumbered as the 9<sup>th</sup> Virginia Continental Regiment. This new 9<sup>th</sup> Virginia Continental Regiment remained west of the Allegheny Mountains throughout the remaining eight months of the tour for which the Monongalia men had been drafted.
