NOTES: Virtually the entire 9th Virginia Continental Regiment was taken prisoner at the Battle of Germantown on 4 Oct 1777. The regiment ceased to exist until 14 Sep 1778 when the White Plains arrangement created an entirely new 9th Regiment by renumbering the former 13th Regiment. In the meantime, the imprisoned officers of the 9th Regiment were taken into the 1st Virginia Continental Regiment, at least on paper. As explained above, when exchanged they were to be eligible to resume command. The above soldiers were still listed as prisoners in March 1779 (http://revwarapps.org/b159.pdf). Most were exchanged on 2 Nov 1780.
