THE CATAWBA INDIAN COMPANY IN SUMTER'S BRIGADE

The following paybill for Captain Thomas Drennan's company of Catawba Indians is located in the South Carolina Department of Archives and History in Columbia, SC, and is included in the accounts audited for claims growing out of Revolutionary War service, file number 3931-A, dated 21 June 1783. For additional information on the Catawbas' service during the Revolution, see Douglas Summers Brown, *The Catawba Indians: The People of the River* (Columbia: USC Press, 1966), pp. 267-270. Note that 10 shillings per day (10/s) was the standard pay rate for an infantry private in the South Carolina militia; 20 shillings per day (20/s) was the pay rate for a mounted private in the South Carolina militia.—MCS

¹ Peter Harris had served previous tours of duty in a battalion of Georgia minutemen (3 July 1777-1 March 1778) and the Third South Carolina Continental Regiment (February 1779-February 1780). While with the Third SC Regiment, he fought in the Battles of Stono Ferry (20 June 1779) and the Siege of Savannah (September-October 1779). After the war he received a bounty land grant and a pension from South Carolina. See Michael C. ² Sumter's Defeat, better known as the Battle of Fishing Creek, took place in Chester County, SC, on 18 August 1780. While camped at the confluence of Fishing Creek and the Catawba River, General Sumter's militia brigade was attacked and defeated by British troops under Lt. Col. Banastre Tarleton. Many of Sumter's men lost their horses, weapons, and clothing during the battle. The pay rate indicated (20 shillings/day) was the pay for a mounted private in the militia.
