State Regiment raised for the Defence of the Western Frontier

The Regiment was raised [from Botetourt, Berkeley, and Hampshire counties] in 1779 in consequence of an Act of Assembly passed at the May Session of that year. The Field Officers were appointed by the Governor [Patrick Henry] in Council and commissioned the 8th November the same year. The Company Officers were appointed by the Field Officers of the several counties that were to raise the men, and entitled to rank from the time of their half quotas [of recruits] being complete; their Commissions bearing the same date of the Field Officers

Strenght of the Regiment not known, as the Officers of the Regiment had not met at the place appointed for rendezvous (which was Albemarle Barracks [4 mi NNE of Charlottesville])

1780 May the 1st Strenght of the Regiment agreeable to the general return of that date
