[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To His Excellency John Rutledge Esquire President and Commander in Chief of the Province of South Carolina

The humble Petition of the Upper Craven County Regiment of Militia.

Sheweth.

That near three hundred of the Militia in the extensive District of the upper Craven County Regiment, have been monthly, from the begening of June, in a manner forced from their Plantations & obliged each to continue a month at the Cheraw Hill, at a time when a Detachment from the Same Regiment, consisting also of three hundred men had actually march'd to the assistance of their Friends in Charles Town, then Threatened with Invasion by a British Fleet & Army hovering on the Coast of Carolina.²

That the Detaining the said Body of Militia at the Cheraw Hill in the most busy Season of the Year, has caused many of them to lose the whole of their little Crops, and has already been Detrimental to the Regiment's District to a vast amount.

That there is not the least necessity, as we your Petitions [sic Petitioners], humbly conceive, for a Fort at the Cheraw Hill or in any Part of the District of the said Regiment, (notwithstanding what some Gentlemen may say, of the District, being surrounded with Foes, for we being certain that the Counties of Mecklenburgh [Mecklenburg] and Rowan [North Carolina] are almost to a Man our Staunch Friends, apprehend the Case to be quite otherwise and that the same Gentlemen might with equal Propriety say the District is surrounded by the Ocean) because we are so happily situated, as to have no Indians, the friendly Catawbas excepted, within two hundred miles of us, with the Country

between thickly Inhabited, and have amongst us but few Persons inimical to the Rights of America, neither do we know of any Enemies nearer to us, then the British Fleet now Cooped on board their own Ships in five fathom Hole, except we regard the poor deranged Highlanders of Anson [County North Carolina] and the other North Carolina Counties adjacent to us as such, and they met with such a Check in the Spring,³ which together with the wholesome Laws lately passed in both Provinces to prevent Sedition & punish Insurgents, has in our opinion, fully convinced those deluded men of their folly, and will effectually keep them quiet for the future, or supposing for a moment that it should be otherwise, we doubt not, but our Friends in those Counties, with a very little of our assistance would be able, once again, to bring them to reason.

That it is impossible, the distance so great, that the Indians can come upon us without our having notice Sufficient to be prepared for them, or that any Enemy whatsoever, formidable enough to Alarm us, can assemble & fall on us before we are apprized of their gathering together; we therefore conceive, that if it is necessary for a Guard to be kept at the Cheraw Hill, or any where else, over our small Stock of Ammunition; that a Subaltern with two Sergeants & twenty five Privates would be quite sufficient for that purpose, & be a monthly saving to the Province of at least Seven thousand [text as posted online ends here. The 3 pages currently attached to the online image of this documents consist solely of signatures as appear below.]
