Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Having married one of the daughters of Colonel William Heth of the Revolutionary Army, who is one of the Heirs and devisees under said Heth's Will; I hereby authorize John G Mosly to present to the Executive of Virginia the claim of my wife for whatever Additional Land bounty may be due on account of Colonel Heth's services in the Revolution; and to look into the Papers, now on file in the Executive Department so as to enable him to ascertain what may be due – May 12th, 1838.

To the Executive of Virginia

I beg leave respectfully to represent to your Honorable body, the Claim for Additional Land bounty for Richard Lorton and his wife Mary, who is the daughter and devisee of Colonel William Heth (or whose Revolutionary services this claim is pressed) and for the others interested –

The authority is herewith filed under which I act.

Enclosed is the Register's Certificate showing that Colonel William Heth was allowed Land bounty for a service "from June 1775 to May 21st 1783,["] and that he received in December 1784 two Warrants making 7777 acres that being for a service of seven years; and that on the 10th July 1810 the Representatives of Colonel Heth received 926 acres, that being for a Service of Ten months – So that, the Land bounty already received was for a service of seven years and ten months – the Vouchers &c are not to be found in the Executive office on which their allowances were made, but it [the image of this document cuts off at the bottom thereof at this point]

filed – By this it will be seen that Colonel Heth's services commenced in June 1775, and ought to have extended to the 3rd of November 1783, making from the 1st of June 1775 to the end of the War (3rd November 1783) (to which period he served & got his Commutation pay) Eight years, five months & three days, which is the exact period of services, if I have made no mistake –

From this, it appears that the Heirs of Colonel Heth are now entitled to an additional allowance for seven months & three days – The Certificate of the Auditor shows that Colonel Heth received his Commutation pay and of course was entitled to receive until the end of the War

In conclusion it is most respectfully submitted, that the allowance all to be for a service from the 1st of June 1775 to the 3rd of November 1783 deducting what he has received.
