Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Personally came before us Jesse Franklin & Jesse Lester Two Justices of the peace for the County aforesaid William York who upon his solemn oath deposeth and saith. That in the beginning of the war between the United States of America & Great Britain he enlisted as a soldier under Captain Henry Dixon for and during the War & served faithfully until the end thereof – in the first North Carolina Regiment and he further swears that he never sold conveyed transferred no otherwise disposed of the 100 acres of land due from the United States until this day to Daniel Wheaton.

[The file contains an elaborate power of attorney dated August 16, 1897 whereby William York names Daniel Wheaton as his attorney to obtain title to the land to which York is entitled as a former soldier of the United States Army. The file also contains a deed conveying such land outright to Wheaton.]
