Bounty Land Claim for James Taylor BLWt1420-100 VA

State of Virginia County of Giles [1 Nov 1828]

I James Taylor aged ninety years do upon oath testify and declare that in the year 1777 I enlisted for the term of during the war and served in regiment Number Eight, under the command of Colonel Muhlenburg [sic: Peter Muhlenberg BLWt1495-850] of the Virginia line and that I continued in the service aforesaid until the close of the war when I was regularly discharged from the said Eighth regiment commanded by Colonel Nevil [sic: John Nevil BLWt1595-500] (the eighth and twelfth regiments having been previously consolidated). I further declare that I have never received a warrant for the bounty land promised on the part of the United States, nor have I ever assigned or transfered my claim in any manner whatsoever; Therefore know all men by these presence that I James Taylor aforesaid do hereby constitute and appoint Anthony Evans Jr of Bedford County to be my true and lawful attorney for me and my name to demand and receive from the Secretary of War of the United States, a warrant for the quantity of land due to me as aforesaid and my said attorney is hereby fully authorised and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purpose above expressed.

I, Joseph Taylor a son and the only heir at law of James Taylor late of the County of Alegheny [sic: Allegheny] and State of Pennsylvania but now deceased, do, upon oath, testify and declare, that to the best of my knowledge and belief, the said that the said James Taylor was a Private in the detachment of Capt Willing [see endnote] belonging to the Virginia line, on Continental establishment, during the Revolutionary War. I do further testify and declare, that I have never received a warrant from the United States for the quantity of land due the said deceased, from the United States; nor do I believe that he ever received it, or transfered his right to it in any manner during his life time. [Power of attorney follows.]

PERSONALLY appeared before the subscriber, a Justice of the Peace, in and for the the county aforesaid, Joseph Taylor and [illegible name] both credible and disinterested persons, who, being duly sworn, did depose and say, that they verily believe that the said James Taylor named in the within declaration, signed by Joseph Taylor served in the Virginia line during the Revolutionary War; That they have understood that he died about 43 years since, viz. on or about the [blank] day of [blank] 18 at New orleans within the Territory of Louisiana leaving no widow, and that he the said Joseph Taylor who is a resident of said County is the reputed and only heir at law of him, the said James Taylor deceased

James Taylor aged Eighty years being duly sworn says that in the month of May 1777 he enlisted at the Town of Dumfries in the State of Virginia for during the war and served in the Eighth Regiment commanded at that time by Colonel Muhlenberg of the Virginia Continental line, in which regiment this deponent continued to serve until some time in the year 1781 as well as this deponent recollects, at which time the 8th and 12th Regiments were consolidated at which time the command of the regiment devolved upon Colonel Nevel, who commanded the said regiment until the close of the war and this deponent was

discharged by him at Winchester some time in 1783. This deponent had the misfortune to have his discharge destroyed many years ago by having his house burt [burnt] by which accident what papers he had were entirely destroyed. This deponent has never received from the State of Virginia any bounty land on account of his services, in the revolution neither has he ever sold, assigned or in any manner disposed of his claim

I John Taylor [S38421] do certify that I was a solder of the 8th Virginia Regiment during the revolution and served with James Taylor from the time of his enlistment until the time of his discharge in 1783 and well know that he performed the services set forth in his declaration and that he was discharged at the time and place which he states Given under my hand this 1st day of November 1828.
