[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

I requested Judge Grimkie [Grimke]<sup>2</sup> to write and make application to the proper Officers of the United States respecting the procurement of the Lands due to me as a Captain in the 5th Regiment of the South Carolina Line of Continental Troops. The Judge just mention[ed] [to] me that I must write to you myself, and to get a certificate from my friend and neighbor General Pickens, that I served in the Continental Line of this State as a Captain, which is enclosed. --

If anything further should be necessary upon the business, please inform me of it. Your attention to my Interest will much oblige, Sir your

That Capt<sup>n</sup> Martin was in the fifth (5th) Regiment under my Command in January 1800,<sup>3</sup> & was Encamped with me at a Plantation of General Bulls, called Sheldon Situated to the

Southward of Charles Ton [Charleston]. That from thence I Obtained General Lincolns [Benjamin Lincoln's] Permission to Go to Charles Ton & further to retire to my Plantation on N°. Santee River, the General Informed me then I mean before my Leaving Chs Ton that Congress had Ordered the younger Regiments to be Encorporated [sic] into the Elder ones & of Course there would be Supernumerary Officers to be deranged – I Afterwards was never Called into Service (the Genl. Saying If the derangement did not Effect me, I Should be Sent for). The Siege of Chs Ton Commenced Shortly after this time, & from Information of Officers I was told That Genl. Lincoln had deranged me. I do Know that by Genl. Lincolns Order Major Vanderhost [John Vanderhorst] of the 1st Regiment was deranged. Also Captain Logan of the 5th Regt for I Saw these Officers after the fall of Chs Ton & they told me so -- also Genl. Marion told me I was deranged from the time that I left Sheldon Plantation as above Mentioned, I never saw Captain Martin -- I did learn that he was deranged & Lived in 96 District in the Upper Part of this Country. I therefore do believe he was deranged -- & If so, It was certainly by Genl. Lincolns Authority

[p 9] Honourable Judge Grimkie Dr. Sir

I received your 2nd letter dated 6th October 1802 respecting the Case of Captain Martin -- I have herein sent you a more full Account than the former Certificate specified, which I hope will be satisfactory -- & is as much as I can possibly say, & under such Circumstances as then Existed -- I Cannot Possibly assert That the Captain was deranged, & the Reason of it is set forth in my present Certificate -- I never saw him since I left him at Sheldon, but many Officers was deranged & I verily believe he was -- & I could only assert from Information of Officers & Genl. Lincolns telling me he had Authority to derange -- Governor Rutledge [John Rutledge] also told me that I was obliged to Genl. Lincoln only for my derangement -- & not to him, as was reported, That he acting in conjunction with Genl. Lincoln -- That he always declared to the Genl. That it was a Continental Matter & That he would have nothing to do with it. -- indeed I was so dismissed with Genl. Lincoln, Partiality to Some, & Prejudice against me -- That by General Marion's Information thereof & Advice -- I was determined to Press a Complaint against him to the board of War & did make Application for such Purpose to Genl. Green [sic, Nathanael Greene], but he Informed me That the war was near Ended, Lincoln was President of the board of War & That shortly he Expected a Dissolution of the Army & That therefore it was not worth my Consideration. I therefore desisted from saying any more on that tread [?].

Dear Sir,

I suppose you will be surprised to receive a few lines from me as it is the time I have wrote you since you left this place. If you recollect before you set out for Washington I was speaking to you concerning a claim I ought to have for Military Land in the Secretary's Office. I was a Captain in the Continental Army in the 5th Regiment of South Carolina Commanded by Colonel Isaac Huger. I hope you will be so kind as to examine the proper office and procure the letters [?] for me if there is any charges on them pay them and I will settle them with you you can either send them to me by post or keep them to you on coming yourself & if my letter is not in the office write me directions what are the necessary means I must follow to procure them you also will be so kind to write me a few lines whether you get them on not for my satisfaction I have no news to write you but what you have heard I am Dear Sir your Humble and obedient Sr.

These may certify that Captain Louis Daniel Martin commission as Captain in the 5th Continental Regiment of South Carolina dated Philadelphia the 30th Day 1778, is now before me and that he served as Captain in said Regiment, with Reputation to himself, and fidelity to the cause in which he was engaged, until the 5th Regiment of the South Carolina line was reduced, in April 1780, as appears by a certificate on the commission, by the Adjutant General of the Southern Army.

Captain Martin is still living, and lives at Pendleton court house -- Certified this 2nd November 1802

Dear Sir

On my return to town from the Circuit I found the enclosed letter & Certificate from General Horry respecting Captain Martin's claim for his Northwestern Land: in addition to which I do certify that Captain Martin was alive in the month of May last & from information received from Major Farrar a few days ago at Columbia he was still so when the Major left his home in Pendleton where Martin resides.

I hope this may prove sufficient authority to the officers concerned to grant his Patents, as he is really poor & well deserves this compensation for his services, which I have often witness, when in the field with him.

Car. Regiment, to bear one Years Interest agreeable to an Act of the General Assembly passed in March 1785 – the 25<sup>th</sup> & from which time is to bear Interest."]
