Addendum to William Robertson BLWt1860-200

Transcribed and annotated by C. Leon Harris. 4 March 2021.

[From bounty-land records in the Library of Virginia in two files assumed to pertain to the Lt. William Robertson of the 9th Virginia Regiment who filed the federal claim for bounty land.]

I do Certify that Leutenant William Robertson entered into the Service of the United States in May 1777 and is now in Actual Service

Winchester 1st Jan'y 1783 P. Muhlenberg BG [Peter Muhlenberg BLWt1495-850] NB the above Lt. Robertson belongs to the Virginia Line Geo Mathews Col [George Mathews VAS520] 3d V. Reg't

I Do Certify that Wm. Robertson was Regularly appointed as Adj[utan]t to the 9th Virginia Reg't on the 24th day of May 1777 And in that Capacity was made prisoner on the 4th of Oct'r 77 [Battle of Germantown, 4 Oct 1777] and continued a prisoner to the 2nd day of Dec'r 1780, and held said Rank to the 22^d Day of Feb'y 1781 at which time he was Rec[eive]d as Lieut't into the Continental Line and arranged to the 5th Virginia Reg't and was appointed Adj't to that Rigement by Lt. Colo. Lewis [possibly William Lewis BLWt1300-400] Com'dt [Commandant] of that Reg't.

April 23rd 1783. Geo Mathews Col 3^d V'a Reg't

Lieutenant William Robertson was appointed an officer (in the then Capt. Fontaine [Fontaine William W7319] Company) at Amherst County – so early in 1775 – as that after raising their quota of men – then marching to Wmsburg [Williamsburg] – Thence under [William] Woodford to the Battle of The Great Bridge [9 Dec 1775] where he distinguished himself & men at the distruction of the British under [Capt. Charles] Fordyce. He was afterward taken prisoner at Germantown Battle and continued (after being exchanged) in the Virg'a Continental line till the end of the War. Given under my hand at Richmond 17 Septem'r 1807

Ro Gamble [Robert Gamble BLWt869-300] form[er]ly a Captain in the Virg'a Continental Army.

Apl 18 1807

William Robertson has drawn for 3 years service: Wm. [undeciphered] Reg[iste]r/ Sept 18.
