Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District of Columbia County of Washington I, Thomas Davenport, Son and one of the heirs-at-law of Thomas Davenport Deceased Do, upon Oath, Testify and Declare, to the Best of My Knowledge and Belief, That Thomas Davenport aforesaid did enter the service of the United States and served as a Captain in the Regiment No. \_\_ under the command of Colonel \_\_ , of the Georgia line; and that he continued in the service aforesaid until the close of the War.

I further declare, that I have never received a warrant for the bounty land promised to Thomas Davenport Deceased on the part of the United States; nor do I believe that he ever received it, or transferred his right to it in any manner whatsoever: therefore,

This day personally appeared before me John S Lewellen one of the Commonwealth's Justice of the peace for the County aforesaid Bedford Davenport, now a citizen of said County and made oath that Thomas Davenport (Father of Thomas, now the Representative in Congress from this District) was a Lieutenant in the Continental Army and subsequently previous to the close of the Revolutionary War promoted to the rank of Captain in the service aforesaid, to the best of his recollection – This affiant further states that he heard said Davenport frequently say in his lifetime, that he had been promoted to a Captaincy in the Service and well recollects that said Davenport bore that title when he returned from the Army – He further states that to the best of his recollection, the said Davenport did continue to serve to the end of the War, and that Thomas Davenport the member above mentioned is his legal representative – Given under my hand & Seal this 8<sup>th</sup> day of March 1832
