Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." 

The <u>Virginia State Library</u> online digital collection relating to bounty land claims contains the following documents relating to this veteran:

Captain Sigismund Stribling entered into the Service of the State of Virginia in a Company raised for the Frontier defense, commanded by Captain John Neville (to the best of my recollection) early in the year 1775 – in the month of September in the same year, I perfectly recollect seeing him on duty at Fort Pitt in November 1776 Captain Neville's Company was annexed to the 12th Virginia Regiment on Continental establishment, then under my command. I further certify that Captain Stribling remained in service until the close of the War in November 1783. Given under my hand at Richmond this 23rd day of October 1807
