Bounty Land application relating to William Scott BLWt2305-300 fn9SC

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of South Carolina District of Charleston: Ordinary's Office Charleston 18 October 1842

I Thomas Lehré Esquire ordinary for Charleston District South Carolina do hereby certify that satisfactory evidence has been adduced to me to prove that Colonel William Scott of the revolutionary Army died about the year 1807 leaving two children, to wit, Richard and Susanna, first married to James Stanyarn and afterwards to T. Lehre, that, said Richard subsequently departed this life and left six children, viz.

- 1. Mary afterwards Mrs. Perry who died leaving one son named James who is the grandson of said Colonel William Scott & of age.
- 2. Elizabeth Ann now Mrs. Poyas widow, who is the granddaughter of Colonel William Scott.
- 3. Ann Bale, afterwards Ann Waring and Ann Ryan, who died leaving 4 children namely Elizabeth Waring aged 17 years, James Ryan aged 12, Ann aged 10, and Thomas Ryan 87 years, who all the great grandchildren of said Colonel William Scott. Price Esquire attorney-at-law has administered and is there trustee.
- 4. Eleanor H afterwards Mrs. Smith, who is the granddaughter of said Colonel William Scott.
- 5. Henry Scott, who is dead, he died intestate, and left a widow, since married, her name is Ann Lawton, said Henry was grandson to said Colonel William Scott.
- 6. Elias B Scott, who is the grandson of said Colonel William Scott.

The aforesaid Susannah, afterwards Susannah Stanyarn and Susanna Lehré, died in 1830, her husband is also dead. She left by her 2 marriages 5 children, to wit,

- 1. Jane Stanyarn, who is the granddaughter of said Colonel William Scott.
- 2. Mary Stanyarn, afterwards Mrs. Flud who is the granddaughter of said Colonel William Scott.
- 5. Thomas Lehré who is the grandson of said Colonel William Scott.
- 3. Julia Lehré afterwards J Davis, wife of John N Davies who is living, said Julia is dead and left 5 children, namely, Martha, now Mrs. Cooper; Julia, now Mrs. Mitchell; Allen, now Mrs. Boyle; William, and Momassina, who is the great grandchildren of said Colonel William Scott.
- 4. Caroline Lehré, afterwards Mrs. Bulow deceased, she left 2 children, viz. Thomas and Caroline; who all the great grandchildren of said Colonel William Scott.

And that the said above mentioned parties are the only representatives and heirs at law in fee of the said Colonel William Scott of the revolutionary Army, now living, or believed to be in existence.

State of South Carolina District of Charleston: I Elizabeth Ann Poyas widow and granddaughter of Colonel William Scott deceased and now residing in Charleston South Carolina & one of the

heirs at law of said Colonel William Scott deceased of the Army of the United States during the War of the revolution, do upon oath testify and declare to the best of my knowledge and belief that the said Colonel William Scott did entered the service in the year 1775 for the term of the war, and served as a Lieutenant Colonel in the South Carolina Continental line, and that he continued in the service aforesaid until the end of the war.

I further declare that I have never received a warrant for the bounty land promised to said Colonel William Scott on the part of the United States, nor do I believe that he ever received it, or transferred his claim to it in any manner whatsoever, Therefore

Know all men by these presents that I Elizabeth A. Poyas aforesaid do hereby constitute and appoint the Honorable Isaac E Holmes to be my true and lawful attorney.... [Boilerplate power of attorney language not transcribed]
