Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## Virginia

At a Hustings Court continued and held for the City of Norfolk on the 1st day of November 1845.

Is ordered to be certified that it has been proved to the satisfaction of the Court by the affidavit of Elizabeth Mathias aged seventy years now filed that Williamson Simmons and James Simmons who were soldiers in the War of the Revolution and who were in service to the end of thereof died intestate and without issue leaving an only brother Willis Simmons who is now deceased, leaving two children James Simmons and Eliza Ann Simmons that Eliza Ann has since intermarried with John Brown – and that the said James Simmons and Eliza Ann Brown are the only heirs at law of the said Williamson Simmons and James Simmons deceased.

I John Williams Clerk of the Hustings Court of the City of Norfolk aforesaid in the State of Virginia do hereby certify that the above is a true copy from the records of the said Court. In testimony whereof I have hereunto set my hand and affixed the seal of the said Court the 20th day of November in the year of our Lord 1845 and of the Commonwealth the 70th.

The Deposition of Mrs. Elizabeth Mathias taken this 23rd day of January 1846 before me John G. Colley at Justice of the Peace in and for the City of Norfolk who being first duly sworn according to law, doth upon her oath state that she is now 78 years of age. That at the close of the Revolutionary War she was living with her uncle Willis Simmons, who was the brother of


James Simmons and Williamson Simmons, that she was well acquainted with said James Simmons and Williamson Simmons, that they enlisted in the American Service in the War of the Revolution for during the war and continued in the service until the war ended that after the close of the War they were both very dissipated, and both of them died before the year 1800 very poor and without issue and that James Simmons and Eliza Ann Brown who was Eliza Ann Simmons are the children of Willis Simmons and the only heirs at law of the said James Simmons and Williamson Simmons deceased.

## [From rejected pension records in the Library of Virginia]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a Certificate issued on the 25th day of June 1783, in the name of Wmson Simmons as a Soldier of infantry for £105.0.3, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January, 1782.

Given under my hand at the Auditor's Office, Richmond, this 23 day of March 1833. Jas E. Heath AUDITOR.

I Certify that I knew Williamson Simmons who was a private soldier in the Revolutionary war of the Virginia Continential line and that he served three year in succession and untill the end of the war and to the best of my knowledge & belief he was Honourably discharged, as Witness my hand and seal this the

12 day of March in the year 1833. Norfolk County to Wit Samuel his X mark Hosier [Samuel Hosier R5244]

This day Samuel Hosier a man who appears to be about 77 years of age personally appeared before me a justice of the peace for the aforesaid county and made oath to the truth of the above statement given under my hand and seal this the 12 day of March in the year 1833
