I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Henry Young has drawn 4666 2/3 Acres of land for Seven years Service as a Captain of the Virginia Continental line, – the Certificate of which he obtained 4000 acres is expressed "for three years Service in the March 1779"

It appears from the above Certificate the Captain Henry Young is entitled to additional land bounty for 9 months service more than 7 years he having been in service until the end of the War. S/L. Coleman
