Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." The Representatives and legal Heirs of Francis Reveley a Capt. as they believe in the Maryland line on Continental establishment during the late Revolutionary War between this Country & Great Britain beg leave to state to the Secretary at War that the said Francis Reveley died intestate some time since, that he never received a Warrant for the Land that he was entitled to for his Military Services, which it is hardly necessary to say was eminently active & meritorious as the public Documents or records of that time will abundantly prove – they therefore respectfully request the Secretary at War will be pleased to further their claim and report the same to the Hon. the House of Representatives of the United States which by a late Act of that house he is empowered to do, so that the Representatives or heirs of the said Francis Reveley may be entitled to receive whatever was due to him for such Military Services. Francis Reveley, deceased.

Norfolk County to wit

I Arthur Emmerson a Justice of the peace do hereby certify that Mrs Eizabeth Clements this day made oath before me that she was intimately acquainted with Francis Revely who at the time of the breaking out of the Revolution resided in the County of Stafford in virginia and entered the service of the Country from that County and was afterwards a Captain in the Continental Line from the State of Maryland. I also certify that the said Mrs Elizabeth Clements is a lady worthy of credit.

Given under my hand & seal this 7th day of September 1833. Arthur Emmerson J.P.

1834 Jany 4 Rejected J.F. [Gov. John Floyd]

January 21 1834 Resubmitted to the council of State and advice required John Floyd Feb'y 13 1834 rejected. J.F.
