Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

No. 414 Daniel Richardson private Virginia Line Warrant issued 22 April 1808 & Delivered to the Honorable B. Bassett

Know all Men by these Presents, that I Daniel Richardson of the County of Accomack in the State of Virginia have this day bargained and sold, and by these presents do bargained, sale and assigned over to Thomas D. Harris of the County of Henrico and State of Virginia all my right, title and interest in and to one hundred acres of land, due me in consideration of my services in the Army of the United States, to the end of the late war with Great-Britain, under the command of Colonel John Green agreeable to an act of Congress, and I do moreover requests, order and direct Henry Dearborn Esquire, Secretary of War for the time being, or his successors, to issue to Thomas D Harris his heirs and assigns, in his or their own name as assignee of me, the said Daniel Richardson a warrant for the land aforesaid, and on receipt of the same, I do hereby ratify and confirm any receipt or other instrument in writing, that he the said Thomas D Harris may necessarily signed, or procure to be signed, in touching the premises aforesaid, as fully as I could do, if filed was personally present. In Testimony whereof, I have hereunto set my hand and seal this 12th day of February 1808

This day Levin Hyslop appeared before me a Justice of the Peace for the County aforesaid and made oath that Daniel Richardson who hath affixed his X mark to the within Power of Attorney is the same person who performed the service stated within, he having enlisted for the war and continued to the end thereof, the said Levin Hyslop having been a soldier in the Continental Army and served in the same Regiment.

The representative of Zorobabel Richardson is entitled to the proportion of land allowed a Private of the Continental line for the war.
