I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina County of Duplin

Thomas Routledge Esquire, of said County, being duly sworn deposeth and saith that he was well acquainted with John McCanne, who was Lieut. in the sixth Regiment of the North Carolina Line, in the late war between Great Britain and the United States, and also that the deponent well knew William McCanne, father of the said John, and Ann his mother, that the deponent never heard or knew that the said John ever had, or left any legitimate issue, and that Nathaniel McCanne the son of the said William & Ann, has always been reputed, and acknowledged, to be the eldest surviving brother of the said John, and his heir at law. And the deponent further says that the said John was said to have fallen in the battle of Germantown [October 4, 1777] in the late war, of which report the deponent has no doubt, as it is universally been believed.
