[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been ormited. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

the service in the Spring of 1778 as a Captain of Dragoons and that he served as such until the year 1780 – when he was appointed Major of Dragoons and served as such until the time of his death, which this Deponent thinks was in September 1781 or 1782. This Deponent was at his funeral he was buried with the honors of war, near Charlestown [Charleston] South Carolina.

Charleston 22nd December 1782

My dear Colonel

On the 14th of this month General Wayne [Anthony Wayne] took possession of the Capital at the head of the Legion and Light Infantry of the Army, the rear of the British embarking at the Wharf as he marched in at the Gate. The greatest Order & Regularity was observed & no violence was committed by either Army on the person or property of a single Individual. Great manifestations of Joy are shown by the people, whilst the more contemplative are looking forward to the immense Advantages which this Event will produce to the Southern States.

Before this reaches you, you must have heard of poor Rudulph's Death [John Rudulph's]. After being sick most of the Summer & Fall & when every body supposed him getting well, he was seized with an Epileptic Fitt & after laying senseless three days expired much lamented on the 8th Instant. By this circumstance the Command has devolved on me, a Weight much too heavy for my Shoulders in the present State of American Politics. For Heaven's sake give your Attention to us if you cannot be with us personally. We are tolerably well cloathed & mounted. Our numbers something above 100 Cavalry & eighty Infantry. We fear Advantage will be taken of this Circumstance to incorporate us with Armand's [Charles Armand Tuffin, Marquis de la Rouerie] Legion & indeed it has been hinted that a Lt. Colo. Ternant [Jean Baptiste Ternant] will go with recommendations from General Greene to this Effect. Take every Means to prevent it, & as Major Edwards will stay no longer, I must subscribe myself

Sir,

Your letter of the 15th came to my hands last evening and I make haste to give you all the information in my power on the subjects of your inquiries.

Major John Rudulph died in South Carolina in the year 1782 after Lieutenant Colonel Lee had relinquished the command of the Legion. His death must have occurred towards the close of the year and while he was commanding officer of the corps. I cannot, however, with certainty state the precise period, although I recollect the event most fully, and the place where it happened. The impression made by the distortion of his features, which had been extremely convoluted by spasms in his last moments, has not yet been erased from my memory. It is unquestionable that he died in actual service, about the time above mentioned and that he entered the Army at a very early period of the war.

Captain Michael Rudulph married a Miss Baker in South Carolina, soon after the Major's death. This lady had relations at Dorchester, near Bacon's Bridge, where she lived with her uncle, a Mr. Cates [?], at the time of her marriage: but her father was of Georgia and resided in the lower country of that State perhaps in the neighborhood of Savannah. I have no doubt that the [indecipherable word] and most accurate intelligence with respect to him and his family might be obtained from Colonel Ferdinand O'Neal who lives upon the sea-coast, some distance to the southward of the city of Savannah. Some of the members of the House of Representatives from Georgia can put you in the way of discovering and corresponding with that gentleman.

I will with great pleasure communicate any other facts within my knowledge which you may deem important, in relation to the military services of the two Rudulphs both of whom were most gallant and meritorious officers. I am surprised to learn that the claims of their representatives for their military services in the war of the Revolution have not yet been adjusted, and am, most respectfully,

Troop of said Corps which was in the Spring of the year 1778. That the said John Rudolph died in said service near Camden in South Carolina in or about the month of September in the year 1781, That he was buried with the honors of war and that this deponent was at his Funeral.

That the said John Rudulph was promoted to the Majors Command about one year before he died and commanded as Major at the time of his death.
