District of Wilmington New Hanover County, North Carolina

On this 13th day of August 1821 personally appeared in open Court, being a court of record for the County aforesaid, Nathaniel Walker, aged 57 years, resident in the County and district above mentioned, who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War as follows: That he entered into the land service 1st June 1782, in the 3rd [sic] Regiment of North Carolina Continental Troops, commanded by Col. Archd Little [Col. Archibald Lytle], and in Capt. Benjn Carter's company of said regiment, and served to the end of the War. That his original declaration was made some time in the month of October 1818, the number of the pension certificate is [blank].

[Archibald Lytle commanded the 1st NC regiment during 1782. Benjamin Carter was Captain in the 2nd NC from ?? 1781 to 1 Jan. 1783, at which time he transferred to the 1st NC. The transcriber did not find Nathaniel Walker in the DAR index, Heitman, Babits & Howard (2004), or J.D. Lewis (2012).]

I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818 & that I have not since that time by gift, sale, or in any manner disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provisions of an Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818. And that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the schedule hereto annexed & by me subscribed.
