[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee County of Wilson} This day Came Benjamin Conn¹ before me James MCadow a Justice of the peace for said County and after being duly sworn deposeth & say that he was personally acquainted with Adam Turner who was a soldier in Captain Majors Company of the tenth Regt. of the North Carolina line in the Revolutionary War and that the said Adam Turner died while in service and left no bodily heir and his Estate descended to his only Brother John Turner and he died and left one son named Benjamin Turner, he further sayeth he is now personally acquainted with the said Benjamin Turner Who lives in White County [Tennessee] & well know him to be the lawful heir of the said Adam Turner Deceased and the only Legal Heir of him the said Adam Turner who died as aforesaid. Sworn to and subscribed before me this 1st day of January 1821
